## **Key Accountabilities**

- Support efforts to ensure all relevant activities are conducted with due consideration of HSE issues and in accordance with agreed procedures.
- Fault find, repair, install, commission and maintain all levels of electrical systems and circuits.
- Perform authorised switching of the Refinery H.V. and L.V. Distribution system.
- Carry out safeguarding, preventative, predictive and corrective maintenance and checks throughout the plants.
- Estimate, plan, organise and obtain resources to efficiently complete activities under personal control.
- Lialse with operations and maintenance teams, and consult with team members as required, in order to prioritise tasks.
- Maintain and be accountable for good and effective time keeping.
- Coordinate team scheduling and priorities.
